- Ensure cybersecurity and data protection through adherence to standards such as ISO 27001.
- Support supplier continuity planning, crisis preparedness, and on/near-shoring strategies.

- Ensure fair and timely payment practices aligned with the Fair Payment Code.

### **Environment & sustainability**

Sustainability is central to our procurement and supply chain strategy. We work closely with suppliers to facilitate Social Value, champion supply chain diversity, manage climate change impacts, support circular economy principles, and promote ethical sourcing. By embedding sustainability into procurement, we drive positive change across key categories, ensuring long-term resilience and environmental responsibility.

#### We will:

- Require suppliers to understand their impact on the environment, adhere to relevant legislation and to have necessary mitigation in place.
- Manage supply chain climate change risks and opportunities, actively reducing GHG emissions across Scope 1, 2 and 3 through supplier collaboration.
- Champion circular economy practices, efficient resource use and waste minimisation.
- Understand supply chain impacts on biodiversity, support nature recovery and contribute to the delivery of nature positive outcomes.
- Support SMEs, VCSEs, and diverse suppliers to build inclusive supply chains, and work with suppliers to contribute to creating social value in the communities we operate.
- Promote and implement ethical sourcing, human rights, fair wages, and anti-modern slavery practices.

### **Delivery of innovation and collaboration**

Innovation and collaboration are key to supply chain excellence. We engage suppliers to unlock new technologies, improve efficiencies, and challenge traditional ways of working. Through strategic partnerships, digital transformation, and knowledge sharing, we ensure our supply chain remains at the forefront of industry advancements, delivering long-term value and sustainability.

- Employees All employees have a responsibility to understand and apply the principles of this policy and comply with the processes set out in the procurement management system.

We will monitor the effectiveness of the policy to ensure we are achieving stated outcomes through review of data and consultation with appropriate teams. Formal review of the policy will take place annually unless there is a significant change in legislation, governance or working practices.
