## The purpose of this cookie notice

### Identity

We are Amey plc (registered office: Chancery Exchange, 10 Furnival Street, London, United Kingdom, EC4A 1AB), and its subsidiary companies.

### Our use of cookies

We are a leading provider of public services, primarily in the UK but also in other countries.

In common with most businesses, we use cookies to help us provide our services and run our business.

### This cookie notice

This is our main general cookie notice that applies across our business, although we may publish additional cookie statements that apply to:

- our operations in specific countries in order to help ensure our compliance with local data protection requirements around cookies
- specific services that we offer

## Cookies

### What are cookies?

Cookies are small text files that are placed on your computer, mobile phone or tablet by web sites that you visit or by clicking on a link to a site within an email. They are widely used in order to make web sites work, or work more efficiently, as well as to provide information to website owners.

### What type of cookies do we use?

We use cookies to:

- remember your browsing preferences when you visit our sites so that we can give you a better site experience
- collect anonymous statistical information about the way you use our websites and their content so that we can improve the way the sites work and the content we make available (for example, we collect information about the number of visitors to the various parts of the sites)
- track how you interact with the updates and marketing materials we send you

The cookies we use are non-intrusive and are used by most businesses.

### **Can I control the use of cookies on my device?**

Most web browsers (including Chrome, Internet Explorer, Firefox and Safari) allow you to control your cookie settings and to delete any cookies already stored on your computer or other devices.

You can control the use of cookies on your device, including deleting and blocking the cookies we and others use, through the browser settings on your device; but please note that any changes you make may affect your ability to properly use our websites.
